Uniforms

Duty Shoes – full shoe, all white, no clogs **White Uniform for Graduation** – closer to graduation you will need to purchase a white uniform (pant outfit or dress) – no cuffs on pants, no drawstrings, no scrubs, white duty shoes (no heels).

**NOTE: All other equipment and uniforms (2 tops, 2 pants, 1 lab coat) are provided as part of Term I equipment fees.

- Act 34 Clearance Criminal Record Check (Approx. \$22.00) Anyone with criminal record should note:
 - Any student with a criminal record <u>may not</u> be able to participate in clinical at our affiliating agencies at the discretion of an individual agency.
 - Any student with a criminal record may not be able to sit for his/her State Board licensure exam – an individual evaluation is done by the SBON Legal Counsel before determining eligibility.
 - Any student with a criminal record may not be able to find employment in healthcare following graduation and passage of State Board licensure exam.
- Act 151 Clearance Child Abuse Record (Approx. \$13.00) ANYONE WITH A DOCUMENTED CHILD ABUSE HISTORY WILL NOT BE PERMITTED TO PARTICIPATE AT PRACTICAL NURSING PROGRAM CLINICAL SITES
- Act 114 Federal Criminal History Record Information (Approx. \$22.60) must be completed before you can attend classes at The Academy. Information will be given to you with the enrollment packet.
- Physical Examination use form provided in enrollment packet; NO OTHER FORM WILL BE ACCEPTED.

- Laboratory Tests Must demonstrate immunity to rubella, rubeola, varicella and Hepatitis B (if completed vaccine series more than 6 months prior); drug screen; copy of test results <u>must</u> be submitted with physical exam.
- **Immunizations** Must have proof of current immunizations for Hepatitis B, rubella, rubeola, varicella (chickenpox), and tetanus.
- 2-Step TB Skin Test or Chest X-ray

Uniform (2 tops, 2 pants, 1 lab coat) ordering will be scheduled for the first day of class. Avenue Apparel will be here on the first day of class for uniform fitting and ordering. Shoes will need to be purchased elsewhere. Student uniforms (2 tops, 2 pants, 1 lab coat) are covered with your equipment fees.

Student is 100% responsible for all costs related to shoes, supplies, physical exam and related blood work and immunizations, clearances and graduation uniform.
